Smt. Asha Jain W/O Shri narendra kumar Jain aged about 58 years R/O Talabpura Lalitpur; hereinafter called the Promoter Trustee (which expression shall unless repugnant deem to include Trustee and his successors) of the Third Part.

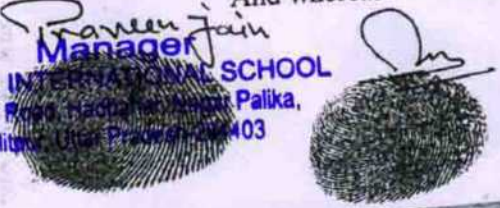

 - d. To undertake and execute work for relief to poor, agriculture development programmes etc. as non- profit making NGO and to actively participate in environment protection and to educate public in this regard.
 - e. To promote and carry out research activities in the field directly and indirectly related with the objects of this Trust.
 - f. To give donations to other charitable Trusts and Institutions which are running for the purposes similar to this Trust or other charitable purposes.
 - g. To provide financial assistance to the poor and needy/ weaker section of the society for promotion of education by way of scholarships, grants, loans, books, uniforms etc.
 - h. To conduct study groups and lecture series.
 - i. To assist the unemployed/uneducated/ persons for setting up their own cottage industry, business or vocation.
 - j. To do any activity which is directly or indirectly related to or incidental to any of the objects of the trust as above mentioned.



- k. To grant stipend, scholarships or any other assistance or otherwise to deserving poor and needy students or scholars, for further course of study and/or research.
- l. To do all necessary things for and incidental to or conducive for the attainment of above objects of the Trust.
- m. Establishment, maintenance or acquisition of any existing library for the benefit of the public at large.
- n. Imparting legal literacy to increase the level of awareness to the masses regarding their legal duties/obligation and rights including those related to child labors, women, children, consumer protection, human rights, social education and other welfare programs, etc.
- o. Imparting population education for creating awareness about population phenomenon and its impact on the quality of life.
- p. To promote activities of peace, communal harmony, national integration and social justice.
- q. Arranging tournaments, championships, variety/cultural programs, concerts, magic shows, seminars and elocution contests for benefit of the public at large and the students studying in the institutions.
- r. Publishing journals, newsletters and other literature for promotion of the aforementioned objectives and programs, this may be taken up by the decision of the Board of Trustees.
- s. To provide medical relief to the poor, distressed afflicted and mentally, physically or psychologically handicapped persons in India, including supply of spectacles and other medical, surgical and remedial appliances and for this purpose to start establish, conduct, maintain, and manage and help

dispensaries, hospitals, medical centres, diagnostics centres, or other inedical or after care institutions.

- a. To carry out objects of general public utility and security such as village uplift, rural reconstitution, public health and hygienics, community development, welfare of women and children, promotion of cottage industries and to start, establish conduct, takeover, maintain and manage and help any institution considered necessary to secure these objects, e.g. orphanages, pinjrapoles, old-age homes, and the like;
- b. To give relief either in cash or in kind to the public in general and specially those affected by riots, floods, famines, fires, epidemics, droughts or other calamities;
- c. To arrange/conduct religious/social congregations.
- d. To run/establish Old Age Homes.
- e. To do any other activity of commercial nature including dealing in Real Estate to generate the income and the said income should be utilized for the purposes as set out hereinabove.

2. **Declaration of the Trust-**

The settler has delivered cash amounting to Rs. 10,000 and will also arrange from time to time suitable funds and other assets for the purpose of the Trust on long term and short term basis to the trustees to hold the same unto and to the use of the Trustees upon trust and with, under the subject to the powers and provisions herein contained.

3. The name of the Trust shall be 'SHRI DEEP CHANDRA CHOUDHARY MEMORIAL TRUST'.



- a. The Trustees will do all the needful to establish and create the infrastructure of the institutions and other set-ups as above mentioned under the trust.
- b. The Settler and all the Promoter Trustees would be life time Trustees and would hold post of Chairman, Secretary/ Manager, Treasurer and Director respectively. They have power to form a trustee management committee with office bearers such as Vice Chairman, Director etc. for the purpose of the day to day management of the activities of the Trust and to fix their scope of work as to fulfill the objects of the Trust. Settler or the Promoter Trustees would be empowered to call trustee meetings, which must take place at least once in every calendar six months. Trustees through an ordinary resolution passed in trustee meeting would be empowered to form sub-committees to manage the operations of various institutions/ colleges etc. and other set ups/ activities/ divisions under the trust as per the objects of the trust. They can also become the members of these sub-committees and the remaining members will be appointed from the faculty and staff and from outside as required.


The Settler and Promoter Trustees shall also act as chairman and secretary/ manager, Treasurer, Director respectively of such sub-committees during their life time. The Chairman or Promoter Trustees would be empowered to call the meetings of such sub-committees as per procedure. In the absence of the chairman, the members present would elect chairman amongst the members present on simple majority vote.





- d. Out of the receipts of the trust Fund which will also include aids, grants, donations, contributions etc. received by the Trust, the Trustees shall defray the expenses for the running and managing of the institutions and other set ups as aforesaid and capital expenditure for erecting building and creating other infrastructure for the purpose of the objects of the trust, but if the receipts are insufficient for that purpose the Trustees may use such portion of the corpus of the Trust Fund as may be necessary.
- e. The Trustees shall also have the power to borrow money from any bank, institution, individual or concern or otherwise on the security of the Trust property and to mortgage/ hypothecate the Trust property for this purpose.
- f. The Trustees through trustee management committee may invest the surplus funds in various movable and immovable properties and securities as they deem fit for the objects of the Trust as per the provisions of Income Tax Act, 1961.
- g. The Trustees have the power to create new trust / society under the management and control of the existing Trust for the purposes of the existing Trust.
- h. The Trustees also have power to receive corpus donation on behalf of the trust by account payee cheques/ drafts or any other legal electronic transfer means deposited directly into the accounts of the trust. Similarly, the Trustees also have power to donate the funds of the trust to other charitable trusts and societies with similar objects or other charitable purpose.
- i. The trustees through an ordinary resolution passed in Trustee meeting are authorized to sell/ purchase any movable or immovable asset for the purpose of the objects of the trust.





5. The Settler and the promoter trustees shall remain trustees during their life time and after their demise, their legal heir would be appointed as trustees in their place, or such other person as desired by such persons by will.
6. **This Trust can takeover/amalgate with any other running Trust/Society having similar aims and objects thereon.**
7. If any of the Trustees becomes bankrupt or found guilty by court of an offence involving moral turpitude or become insolvent or resigns from his/ her post the remaining trustees may appoint another trustee in his/ her place.
8. That the Trustees may accept any gift, donations, aids, grants etc. from individual, concern, body corporate or government institutions or otherwise from any legal sources based in India and abroad for and on behalf of the Trust for the objects of the Trust.
9. In case there is a difference of opinion amongst the trustees, the decision of the majority of the Trustees relating to the Trust shall be binding and be effectual and shall be carried out.
10. In case of failure of the Trust for want of its objectives or Trust having been impossible of performance, the Trustees shall move the court of jurisdiction for applying the remaining Trust fund for similar project or for any of the objects of the Trust.
11. The Trustees shall in no case be liable for any loss to the trust unless the trustees are found guilty of any act of fraud.
12. This is a public charitable Trust. The properties of the Trust shall in no case revert to the founder and trustees or their descendants or to any other person on their behalf.
13. Settler or promoter trustees are authorized to open and maintain a savings/ current a/c with any schedule bank in the name of the Trust, which shall be operated by

The Trustees may from time to time frame rules for the conduct and regulations of the meetings of Trustees and sub committees for operations of the Trust and/ or divisions of the trust. In the absence of such regulations:

- a. 51% Trustees shall form a quorum for a meeting of the Trustees.
- b. The meeting of the Trustees shall take place at least once in every quarter of the year.
- c. Any revision, alteration and addition to the existing rules of committees and sub committees may be done in a meeting of the Trustees by passing it with a majority vote in favour of the resolution.

25 No part of the Trust fund, either the corpus or the income there from, shall be utilized for any object other than that of the trust hereby created.

- i. The regd. office of the Trust shall situate at 161, Talabpura, Lalitpur- or such other place as determined by the Trustees in their meeting.
- ii. For the purpose of assessing the stamp duty the value of the Trust property is Rs. 10,000 as contributed by the Settler in cash.

- (Settler/Promoter Trustees). Any change in powers related to bank operations can be made in the trustee management meeting duly conveyed to the concerned bank.
15. That the trustees in the management committee of the Trust shall be able to purchase and sell any immovable property in the name of the trust/ on behalf of the trust to fulfill the objects of the trust as approved in the trustee meeting. In such case the Settler or promoter trustees would be authorized to execute the documents/ deeds on behalf of the trust. In case they are not available, then trustees in a duly convened trustee meeting would authorize any other signatory in their place amongst the other existing trustees to do the needful.
 16. That the Trustees shall have the power to refer any dispute to arbitration, and to file suits on behalf of the Trust, and to compromise or compound all actions, suits and other proceedings and all differences and disputes touching the trust properties, and to adjust and settle all accounts relating to the Trust and/ or its properties.
 17. That the Trustees shall maintain proper books of accounts for the Trust and shall draw its Final Accounts on 31st March each year and will also get them audited by a qualified Chartered accountant.
 18. That the Trustees may reimburse to themselves and pay and discharge out of the Trust fund all expenses incurred in or incidental to the execution of the objects and purposes of the trust. If they act in any additional capacity in the day to day affairs of the activities of the institutions and other set ups of the Trust, they may be paid reasonable remuneration for their additional services.
 19. Every Trustee will be at liberty to resign on giving three months' notice to the Trustees committee of his/ her intention to do so.
 20. That the Trustees will have the power to amend / make new rules/ clauses in the trust deed with 2/3rd votes in favour of the resolution to do the needful in furtherance of the aims and objects of the trust.
 21. In case of dissolution of trust the assets of the trust would be transferred to another trust with charitable objects or as per the directions of the competent court, if required.

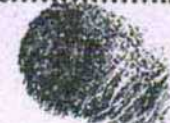
